



FCPA Enforcement in the New Administration

- FCPA was largely ignored by DOJ and SEC for 30 years
 - ➤ DOJ/SEC brought approx. 70 corporate cases totaling only \$50 million in fines
 - > FCPA enforcement began to increase in 2008
- Record enforcement since 2016
 - > DOJ FCPA Unit has grown to 39 prosecutors, up from 19 in 2015
 - > FBI now has 4 ICUs (DC, NY, Miami, LA), up from zero in 2015
 - > Enhanced cooperation with foreign governments
 - Over \$18 billion in global penalties since 2016 alone
 - 13 coordinated resolutions with foreign authorities since 2016 (\$16.5 billion in total penalties)
 - Over 125 individuals charged since 2016
 - Targeting CEOs, GCs, Directors, Hedge Funds, Bank Execs, etc.
